of guessing. The water system appears to be in good shape. The water level at the well is steady. The water tanks are full. We do not have any major leaks or mechanical problems. The monthly bacteriological water samples came back from the lab as Absent.

Dan and I are still working on a "permanent" solution to the water supply for the remaining seven Shrine Tract cabins in the old Shrine Camp. We are attempting to connect to the Laguna campground water supply via some old Shrine Camp infrastructure. The problem is the Forest Service is adverse to any ground disturbance. It is a slow process but we are making progress despite the hurdles.

The Forest Service has finally removed all physical traces of the former Shrine Camp. Too bad they did not think it important to leave some historical reference to the Shrine Camp that had been there almost 100 years.

The Forest Service is working on establishing an alternative access to the Shrine Camp tract cabins from the Laguna Campground.

Our Treasurer, Mary, is still laid up recuperating from a broken foot, but she is still on the job collecting the annual dues/fees. For those few who are delinquent in their payments: please make an effort to meet your obligations as members of the MLIA. The invoices are sent out every year in October. If you do not receive an invoice then, you need to contact MLIA to find out why.

We do have occasional difficulties communicating with cabin owners due to address changes or ownership changes or responsible party changes. If you are having difficulties, please communicate with Mary to explain your situation so that we are aware of what is going on. Mary and the Board take these annual payments seriously and non-payment has consequences.

## Winter Cabin Safety

During this winter, it is a good time to check your heater and fireplace flues and dampers for proper operation and that they are free of any obstructions and soot build-up. Test all smoke detectors and carbon monoxide detectors and replace the batteries if they are older than one year. Please check your detector manual for requirements to replace batteries.



As a reminder, SDG&E will set-up power Community Resource Centers (CRC) during a Public Safety Power Shutoff (PSPS) or an emergency evacuation of our community. Check the SDG&E website for exact locations of these charging stations. The SDG&E website shows these CRC locations, outage maps, weather reports, area cameras and power shutdown status. Be sure to sign up for weather and power outage warnings and alerts to your cell phone and email through your SDG&E online account.


Our next MLFSC meeting will be on April 15, 2023. This date, time and location to be confirmed at a later date. We will send out an email with the details.

- Cabin Fee Act 80-85% of Forest Service monies will be allocated back to the local forests beginning in 2025.
- Permit Renewal The Cleveland National Forest is due to re-issue cabin permits in 2028.
   This will rapidly approach and it is going to take ALL of us to prepare.

You can pose questions on the community forum and hear back from other cabin owners and NFH leaders. The National Conference is May 5 &6, 2022, Lake Tahoe, CA.

### Pine cones are amazing

What do pinecones and mathematics have in common? Fibonacci, of course!

The Fibonacci sequence is a series of numbers where the sum of the two previous numbers gives the next number in the sequence. For example: 0, 1, 1, 2, 3, 5, 8, 13, 21, 34, 55, 89 and so on. This series of numbers was first described in the mathematics of India around 200 B.C.E. The sequence appears frequently in nature, as in the spiral whirl of a seashell. It also appears in the spiral shape of pinecones.

Find a pinecone. First, look at it from the top down. Notice how the bracts open in a spiral fashion.

Next, turn the pinecone over. Find the center of the cone, where it attached to the tree branch. Then note the spirals of bracts that come out of the center. If your pinecone is large enough, you should be able to count the spirals going in both directions—clockwise and counterclockwise. (Use two different colors of magic marker to really see how it works.)

The number of spirals should be two adjacent numbers in the Fibonacci sequence.

The sample drawings show 8 going in one direction and



13 in the opposite spiral direction.



Nature is full of Fibonacci spirals—the petals on a flower, the Nautilus shell, spiral galaxies, and more. Check out https://insteading.com/blog/fibonacci-sequence-in-nature/ for more examples.
