I have been spending some time attempting to actually locate and mark our main water lines. It is one thing to look at an old map that indicates where the water lines should be and another to actually locate them. To our surprise the old maps are fairly accurate though.

The State assumed the oversight of the small water systems in the county last year taking over from the SD County Dept of Environmental Health. They have been surprisingly quite responsive to our questions and also more demanding and more costly. Like your cabins, the costs of running the MLIA are increasing. Our Treasurer, Mary Ladewig, is keeping us updated about this every quarter.

The FS Fire Prevention folks will be starting the cabin inspections in June and will hopefully finish in July. The cool, dry weather of late has allowed the FS fire fighters to set some planned and needed prescribed burns. This smell of smoke in the air this time of year is a good thing for all. Now is the time for the cabins to do their part and clean up their lots - hard, dirty, hot work, but necessary.

The Chili Fest in April was really enjoyable and delicious. Our new Social Event Coordinator, Toni Cleveland, is IN CHARGE and organized! She has great ideas and lots of enthusiasm. Can't wait for the next event!! At our social events we usually have some fund-raising efforts. Since the MLIA is NOT a charitable non-profit, the Mt Laguna Fire Safe Council will be managing the fund-raising activities at the social events from now on. The MLIA will handle entry fees to cover event costs.

Laura Bier, a Director, is going to be taking over the duties as webmaster from Eugenie, who will continue to publish the newsletter.

Special Notice to Cabin Owners about our MLIA cards

In the past, MLIA issued green cards to cabin owners showing proof of cabin ownership. We will no longer be sending the "green cards" as we are moving to all online documentation.

If you wish to carry proof of cabin ownership in your car or wallet, take a photo or make a copy of your latest permit letter from the USFS, your MLIA bill, and/or a recent SDG&E bill. If you have a cell phone, you can take photos of these documents to have with you at all times.

Cleveland National Forest Recreation Residence Assistant

I am a San Diego Native that grew up camping, hiking, mountain biking and sledding in the Cleveland National Forest. I attended California State



University, Chico where I obtained a bachelor's degree in Recreation Administration and a Minor in Geography. During my time at the University, I was a student and teacher's aid of an Outdoor Leadership Program and Trip Leader for the Associated Students Outfitter Guide, Adventure Outings.

I started my career with the United States Forest Service in 2009 as a Wildland Firefighter, mainly serving on Engine 348 out of Descanso. Additionally, I gained experience in Fuels Management and prescribed burning projects to reduce hazardous fuels and provide fuel breaks for communities in the wildland urban interface. In 2022 I was presented with an opportunity to work in recreation taking care of campgrounds and other facilities. I am now the newly hired Recreation Residence Assistant working out of the Supervisor's Office in Rancho Bernardo.

2023 Dumpster and Brush Pile

The community-only dumpster and brush pile are located for this season to the Old Air Force Station. (See map)

This site is open for our use 7 days a week from 8:00am to 6:00pm <u>only</u>. This site is for Mt Laguna community members only, no contractors allowed. Please follow these rules when using the dumpster and brush pile:

- 1. Our lock has yellow tape and the combination was previously emailed to all cabin owners.
- 2. Always close and lock the gate behind you when you enter and lock the gate when you leave.
- We are only allowed to use the designated brush pile and dumpster, no other areas.
- 4. DUMPSTER

Leaves, grass/weed cuttings, pine needles and pine cones <u>only</u>. No dirt, rocks or bags allowed.

- Unload to the back and up to the top edge of the dumpster first. Please close the doors after unloading.
- 5. BRUSH PILE

Native shrubs, brush and branches up to a maximum of 6" in diameter <u>only</u>, and <u>only</u> from the Mt. Laguna community.

Unload toward the back of the brush pile first.

- Please keep the site clean of trash. Construction debris is not allowed at this site.
- Follow the signs that are posted to and from the brush pile/dumpster <u>only</u> and drive slowly

while at this site.

We will lose the usage of this site if we do not follow these rules



My husband, Dan, and I attended the 2023 National Forest Homeowners Association Meeting in Tahoe, CA. in early May. We met Sharon Leach, NFH Executive Director, and members of the NFH Board. We encourage each of you to attend if you have the opportunity; it is well worth the time.

The theme of the conference was **Resilience** and included numerous interesting presentations.

Kevin Orth, NFH Director/Chair of NFH Stewardship Committee, discussed **preparing for wildfire emergencies** and how important this is to each cabin owner and tract. Our own Frank Kalinoski is a member of this Stewardship Committee. The committee's number one goal is Fire Preparedness with emphasis on increasing focus/funding for fire preparedness activities with the Forest Service (FS).

They are developing framework guidance for tracts to work with the Forest Service on Firewise activities, and exploring other activities/materials that support fire preparedness. Each cabin owner should look for an NFH fire survey in their email this summer. Please do participate.

NFH President, Meredith Randall, presented **Advocacy** 101 and how each of us as cabin owners need to advocate for the recreation residence program both locally and nationally. Results of the NFH Economic study and how cabin owners' local spending supports the community were shared. A Terrific NFH Conference!

The **Cabin Fee Act** was also discussed. Beginning in 2025, all special use permit fees will be retained by the Forest Service and come back to the forest that generated these fees. Fees will support the recreation residence program and other recreational programs such as campgrounds, picnic areas and trails. NFH proposed how these funds should be used at the local level

Permit Continuation was presented by past NFH president, Doug Gann. Cleveland National Forest, along with all other National Forests, except the El Dorado Forest, are due for permit reissuance in 2028. Preparation for reissuance usually starts 2 years before the due date and is a combined effort of USFS and the local cabin organization, i.e., MLIA. Every cabin owner can prepare by reviewing their permit, and being in compliance with what it says. Noncompliance can create a situation where a limited permit for one year is issued to a cabin owner until compliance is achieved. NFH is also advocating in Washington to get language in the new permit changed as it says that 5 months is the maximum time cabin owners can be in their cabins each year.

Jeff Vail from the USFS Washington Office spoke. It was refreshing to hear him emphasize the importance of a partnership and transparent communication between USFS and Cabin Owners. Hope this is threaded throughout all levels of USFS.

A Letter to All Cabin Owners from NFH Sent by Deb Cowlishaw, NFH Director

Allocation of Permit Fee Funds

Currently our special use permit fees go to the U.S. Treasury. The playing field is shifting and cabin owners are gaining an advantage. Thanks to years of tenacious effort by NFH leadership and the foresight of some of our elected officials on Capitol Hill, the permit and transfer fees we pay will be retained in the Forest Service beginning FY 2025.



The Forest Service is budgeting for 2025 now, this summer. The Forest Service Washington Office has told NFH that 80-85% of the fees retained will be allocated proportionally to the forests with cabins. So, we urge you to give thought about the best use of these additional funds.

Permit Reissuance

At our 2023 NFH Conference held at Lake Tahoe, NV our breakout session on permits explained the Consistency Review Continuation Determination (CRCD) process that the Forest Service begins two years before the expiration date of the cabin special use permits on that forest. The CRCD process has started for those who's permits expire December 31, 2024. The next expiration date will be December 31, 2028. This breakout session content is available on NFH's website.

Restoring Cabin Numbers

NFH recognizes that without intervention the number of cabins nationwide will continue to decline and soon there may be too few cabins for this to be a viable program. NFH is aggressively pursuing many pathways to restore cabin numbers.

One path described is about giving guidance to local cabin associations to strengthen their relationship with their local forest. How are your relations with the local Forest Service Permit Administrator and other staff? Has there been turnover of cabins and are there any neglected cabins where owners seem incapable or uninterested in maintaining the cabin?

Take a walk on the wild side!

Well, maybe not so wild, but the Wooded Hill Nature Trail is a wonderful walk with flowers and views galore. Off Sunrise Highway, take the road marked for Wooded Hill and Agua Dulce trailhead. The nature trail will be on your left across from one of the entrances to the Wooded Hill Group Camp. Park near the trailhead and take the loop trail. It's a 1.5 mile loop, and ascends 300 feet. Along the way, there's an option to cut the walk short and take a different loop, but it's worth it to go to the top.

At the top the views are spectacular. On the way you have opportunities for plant viewing. When we hiked it in mid May, the flowers were just beginning to come out. By now many should be in full bloom. There were hundreds of Indian Paintbrush getting ready to open. The Checker bloom were also beginning to open.

We saw some miniature Lupine, *Lupinus bicolor*, as well as wild Pea vine, *Lathyrus vestitus*, and a number of tiny yellow Violas, *Viola pedunculata*.
