
All cabin owners should have received a series of documents prior to the meeting—agenda, committee reports, candidate statements, ballot, etc.

I met Frank when we initially bought our cabin in Fall 2021. Dan and I were trying to obtain USFS permission for a septic system replacement. Frank will probably remember my phone call – I know I will. I was in tears (probably more than tears, possibly hysterical) and wanted to enlist the support of MLIA.

The Forest Service had just communicated that we look at septic replacement alternatives such as: a shared septic with a neighbor, an above ground storage system or a composting toilet. Frank openly listened, tried to calm me and then went to our defense with the USFS, possibly impacting his own relationship with the local Ranger, but he advocated for us.

Cabin owners, you had no greater advocate than Frank behind you in supporting the Cabin Program! I want to thank Frank for his endless support and years of service to MLIA. Many hours, many heartaches, many accomplishments, and all volunteer! Frank not only gives his time to the mountain, but he is active on national committees with the National Forest Homeowners Association.

In 2013, disaster struck on the mountain. The Chariot **Fire** tore through the Shrine Camp, destroying nearly all of it. Ten USFS cabin owners lost their cabins permanently, with no option to rebuild. The remaining seven had their Use Permits suspended indefinitely. It was a terrible reminder of the power of nature and the power the USFS holds over all of us. From the day I first approached Frank suggesting the remaining cabin owners to join the MLIA, he has been a tireless and effective advocate as well as a trusted partner.

Ten years later we have new access, the mess has been cleaned up, the fire scar is fading, and we are testing a new, permanent source of water. Frank has been right there through all of the twists and turns. The Shrine Tract cabin owners are incredibly grateful for Frank's tireless efforts. Frank has set a high bar for future leaders of the MLIA with his broad vision of the strength and power of the MLIA.

## New MLIA Bill Payment Process

MLIA is implementing electronic invoicing for fiscal year 2023-2024. This change will reduce time and costs to complete the billing process. The MLIA annual invoice will be sent to the cabin owner email on record for each cabin. Payment is due on or before 30 days from the invoice date to avoid late fees, and can be made electronically or by check.

#### To pay by check

If you don't want to use Zelle, pay with a check and send to: MLIA P.O. Box 91 Mount Laguna, CA 91948

#### To pay electronically

MLIA has set up Zelle at Chase Bank. Check if your financial institution supports Zelle at <u>https://www.zellepay.com/get-started</u> or call your bank/credit union. MLIA cannot accept PayPal, ApplePay, Venmo or individual credit or debit cards at this time. If your bank supports Zelle they should be able to walk you through the process.

#### How To pay online with Zelle:

- 1) Verify that your bank supports Zelle (See info above)
- 2) Go online to your bank or credit union and access your account
- 3) Look in the menu options for "Send Money with Zelle"
- 4) Access the Zelle menu. Click "Send Money"
- 5) Under "Select Recipient" enter "Mount Laguna Improvement Association"
- 6) Add <u>MLIAcabins@gmail.com</u> for phone number or email
- 7) You may be asked to verify your request through text or email (two step verification) to add a new payee
- 8) Click "Send and Invite" or "Send" (there may be slight differences for each bank/credit union)
- 9) A screen will appear that allows you to enter the amount of your bill. It should also show which account it's being sent from.
- 10) You have a chance to "Review" the transaction. If you have an opportunity for a memo, please add your cabin number and invoice number
- 11) Complete your transaction and the money is sent!



## **Lots of Rain and Cabin Access**

Mt. Laguna received a whopping 7.11" of rain from Tropical Storm Hillary. It was a welcome reprieve leading up to fire season. It also suspends the prescribed burn program for a few weeks and provides our forest with much needed moisture. Our cabin access road maintenance and preparations were put to a true test by so much rain. Fortunately, the rain was steady over a long period of time rather than a prolonged downpour.

Culverts are particularly troublesome if not cleared prior to a weather event of this magnitude as reflected in the photo at the entrance to Burnt Rancheria. This culvert was plugged causing the water to undermine the entrance from Sunrise Hwy. Thank you to Lois and Don Hall, Cabin 563, for stepping up to mitigate the damage.

Consideration must always be given to local topography when using water bars, diverting flows to open space rather than down a road, and environmentally friendly materials that bond together to form a stable foundation for emergency class size vehicles as well as our own

family vehicles. Hydrology is a very important aspect of life on our mountain. The MLIA Board will be reaching out to our Forest Service partners to develop a more comprehensive maintenance and erosion prevention program for the future.

Thanks to all of you that have volunteered and contributed to access maintenance in the past and those that will in the future.

# **STAYING FIRE SAFE**

#### The next MLFSC meeting is scheduled for Saturday, October 21st at 10:00am at the Red-Tailed Roost.

An invitation will be emailed prior to this meeting and we will be using the agenda from the August 19<sup>th</sup> meeting. Our meetings will conclude with the November 18<sup>th</sup> meeting, and elections will be held at this meeting. If you are interested in a Board position or Director position, please contact me at the email below.

Forest Service and CalFire re-inspections have been completed. If you are not in compliance with your defensible space clearing, please do so as fast as possible. This helps to reduce the wildfire fuels and risk in our beautiful forest. The Forest Service and AT&T are currently working on identification and removal of hazardous trees around the communication lines. AT&T is also in the process to survey and remove the old and unused wood poles that carry their lines. They plan to attach their lines to the SDG&E's steel power poles. Duration and completion of the work is unknown.

The Forest Service plans to station a group of firefighters at the old CalFire station as a Fuels Reduction and Management team for our area all year round. More information and details will be announced by the Forest Service as the plan develops.

## **CLEAN-UP TO STAY FIRE SAFE**

Thanks to our new Battalion Fire Chief, Troy Bell, Camp Ole Captain Billy Simmons and the whole Camp Ole crew for setting up the community only brush pile and dumpster site at the Old Air Force Station. It is open for our use 7 days a week from 8:00am to 6:00pm <u>only</u>. We need to follow the rules so we don't lose usage of the site.

Please follow these rules when using the dumpster and brush pile.

- 1. Our lock has yellow tape and the combination is 1225.
- 2. Always close and lock the gate behind you when you enter and lock the gate when you leave.
- 3. We are only allowed to use the designated brush pile and dumpster, no other areas.
- The dumpster is for leaves, grass/weed cuttings, pine needles and pine cones <u>only</u>. No dirt, rocks or bags allowed. Unload to the back and up to the top edge of the dumpster first. Please close the doors after unloading.
- 5. The brush pile is for native shrubs, brush and branches up to a maximum of 6" in diameter **only**, and **only** from the Mt. Laguna community. Unload toward the back of the brush pile first.
- 6. Please keep the site clean of trash. Construction debris is not allowed at this site.
- 7. This site is for Mt Laguna community members only, no contractors allowed.
- Follow the posted signs to and from the brush pile/dumpster <u>only</u> and drive slowly while at this site.

Please email your volunteer hours for your home defensible space clean-up to <u>mountlagunasafe@gmail.com</u>.

These hours are now required to submit for SDRFF/SDG&E Grant reporting records.

## **Equipment Available for Clean-up**

- 2. Gas powered trimmer and pole saw for \$20/1 day.
- 3. Gas powered wood splitter for \$30/1 day.

## Monies Coming Back to Our Forest!

## Solving Septic System Issues

Historically, NFH and cabin owners were instrumental in drafting the Cabin Fee Act (CFA) that became law in December 2014.The CFA limits the increase in annual national fees and allows you to more easily afford to be a cabin owner.

As part of the Cabin Fee Act, starting in 2025, these fees are slated to go back to the forest to administer the recreational residence program and other recreation programs carried out on National Forest System lands. Up until now, cabin fess paid to USFS went into the general governmental fund. NFH submitted a proposal, recommending how these monies (retained funds) may be distributed and used by the Forest Service. MLIA discussed the fund allocation proposal at the August Board meeting. Attendees suggested ideas about how the funds could be allocated including: cabin access improvements and maintenance, road and trail access, hazard tree removal, plans to clear non-compliant lots, maintenance and fire suppression projects, water system maintenance and improvement.

MLIA leadership is following up with Cleveland National Forest (CNF) Leadership regarding our recommendations for these funds.

### Need a new tank or leach field? System backing up?

First, call a septic company to troubleshoot the problem. It may simply be a clog in the line or a need to pump your tank. Septic companies can send a camera down the pipes and determine blockage locations and/or septic tank location.

If a new septic system (tank and/or leach filed), is needed, a USFS Septic Request Form must be completed. The form details what proposal information is required before it is sent to Andrew Cheskaty, Assistant Permit Administrator. The proposal form must be fully completed; if information is missing the request will not be considered.

The proposal should include: reason system needs repair/replacement, scaled diagram of cabin and surrounding area (cabin, outbuildings, driveways, location of old septic tank and leach field) and contractor's name. The contractor needs to provide information about: new septic tank and/or leach field location and associated pipes, size and type of septic tank and leach lines, action regarding old septic system, (i.e. removal or left in place and crushed), action regarding displaced soil, equipment to be used, and how equipment will access the site.

Email Andrew Cheskaty, for the Septic Request Form (<u>Andrew.cheskaty@usda.gov</u>.) Andrew will *be the point of contact for your proposal* and process your request through the USFS system.
