SDGE and trees: It is their responsibility to cut limbs going from pole to pole.

It is our responsibility to trim trees between the poles and our cabins.

There was a question about the letter sent in May to cabin owners regarding materials.

What if something like a Trex deck was already approved? Ans. It should be okay.

Keep records.

Make sure your trees are limbed up 13'6" on the road to your cabin, so fire trucks can get through.

Perhaps a sign for gate.

Good to have water and fire extinguisher ready when working

Cabin Inspections haven't started yet, but should next week.

Workers start in Alpine, then Guatay, Descanso, Pine Valley, and finally Mount Laguna.

A total of 245 cabins with all areas

Only inspecting fire clearance this year, unless another problem is seen, and that will be referred to Andrew.

The same form as last year will be used

Reminders are sent if not in compliance at first.

A cabin owner could lose their permit if there are problems

A reminder to be very careful if using trimmers with metal blades as they can send sparks
